Thank you Senator Casey

Senator Robert Casey was instrumental in sponsoring and passing the bi-partisan Safeguarding Treatment for the Restoration of Ecosystems from Abandoned Mines (STREAM) Act, which infuses millions of dollars into treatment and remediation of abandoned mine discharges and landscapes. Perhaps most importantly, this law allows funds to be set aside for the long-term operation and maintenance of treatment systems, which are critical infrastructure for stream health. Casey spoke at the Oven Run re-dedication ceremony in September.

The Pennsylvania Council of Trout Unlimited and the Stonycreek Conemaugh River Improvement Project acknowledged Casey's support and stalwartness and wrote him thank you letters in February. If you would like a copy of the PATU letter, contact Len Lichvar.

Good News!

In December, an application was submitted for a grant of \$3,500 to be used on phase two of the Stewart Run Project. This grant was sponsored by Berkshire Hathaway Energy, formerly Dominion Energy, and administered through the Western Pennsylvania Conservancy. We were one of sixteen applicants, so the competition was rough. We did make the cut and were granted the full amount approved for \$3,500. Phase two is budgeted for \$4,600 so this will off set the costs considerably. No firm date has been set but the work will likely be done in August. Last August, structures were placed as part of phase one of this three phase project. Butch inspected this work in March and found the structures functioning as intended. The stream, which is a tributary to Blacklick Creek, was then stocked by the PA Fish and Boat Commission and volunteers.

The grant will be presented on Wednesday, April 19, at Chestnut Ridge Resort near Blairsville. A networking luncheon is scheduled from 10:00 am to 2:00 pm. We are to have two representa-



tives from the chapter attend, so let Butch know if you are interested.

Rivers Conservation and Fly Fishing Youth Camp by Dave Wright

The membership of MLTU will be proudly sponsoring a junior from Bishop Carroll High School in Ebensburg at this year's Rivers Conservation & Fly-Fishing Youth Camp to be held at Messiah College, Grantham PA. The Cumberland Valley Chapter hosts the camp that is in its 28th year. Up to 24 students will be participating. "Classes include principles of ecology, hydrology,

trout stream entomology, aquatic invertebrates, hydrology, watersheds, the biology of pollution, reptiles and amphibians, trout behavior, and riparian corridors." The camp will be Sunday, June 18 through Friday, June 23. Indoor activities will be held in the campus Jordan Science Center. Outdoor activities are scheduled for the grassy areas of the campus, and fishing activities will be along the famous Yellow Breeches Creek, which flows through the campus. Hopefully, the sponsored student will attend a future chapter meeting and present a report on this unique educational experience. The total cost to the chapter is \$550, which includes tuition, all course materials, and room and board.

If you are a novice fly tyer, the experience and satisfaction of landing and releasing trout on a fly that you tied yourself is an immeasurable accomplishment.

Editors note: The following is a letter PATU President, Len Lichvar, wrote and sent to PA Fish and Boat Commission's Executive Director, Commissioners, and Fisheries staff.

Pennsylvania Council of Trout Unlimited (PATU) represents approximately 17,000 members in Pennsylvania. The organization is dedicated to cold water conservation including the protection of PA's trout streams, rivers, and still waters.

Of major interest to PATU is the proposal to amend 58 PA Code 71, 73 which originally addressed the introduction of a Notice of Stocking and a Stocking Authorization requirement for any entity to stock fish in PA's waters. PATU feels that this is something that is long overdue, and we have been a strong supporter of this change.

At the most recent meeting of the PFBC Fisheries and Hatcheries Committee in January, it was noted that any reference to a Stocking Authorization has been totally omitted from the proposed change to 58 PA Code Ch. 71, 73 and now only included a Notice of Stocking. As explained by staff, the required Notice of Stocking would provide

staff with data indicating what, where, and what species the various entities are stocking in PA's waters. PATU supports this initiative.

Originally, staff explained that the Stocking Notice and the subsequent data gathered would lead into informed implementation of the requirement for all entities to obtain an authorization to stock fish. PATU has held the position that the requirement to obtain a Stocking Authorization is of great importance to effectively manage PA's fisheries, and we have strongly supported this initiative.

While there was some reference to revisit the stocking authorization issue expressed by a few Commissioners in the future, by having removed all language pertaining to a stocking authorization, there would be no requirement to do so in the future.

PATU believes that the implementation of an enforceable Stocking Authorization would contribute greatly to better management of PA's waters. We would strongly urge PFBC to reconsider and reinsert the Stocking Authorization language into the proposal to amend 58 PA Code Ch. 71, 73.

Dear Gary and Area 8 Fisheries Management Staff,

The Mountain Laurel Chapter of Trout Unlimited (MLTU) would like to inform you that there will be a Coldwater Conservation Plan for the entire Bens Creek watershed in Somerset County completed by early March of this year. Among the data and information will be suggested resource and fishery management recommendations that we would like to discuss in person with you and your staff at a later date.

Until then, in response to official action taken by the chapter, we would like, in the short term, to strongly advise that you ensure that the Class A wild trout designated section of the South Fork of Bens Creek does not receive hatchery raised trout within the designated boundaries of Jenners Lane and Keafer Hill Road.

We make this known to you because we previously witnessed PA Fish and Boat personnel, which included three PFBC Commissioners and the PFBC Executive Director, multiple Waterways Conservation Officers, and volunteers, placing hatchery trout within that designated Class A section during last year's pre-season stocking of the stream. We understand how this situation may have occurred inadvertently; however, this action is still a clear violation of PFBC Fisheries Management Policy.

In order to address this and related issues that are relevant statewide, when the Conservation Plan is finalized we want to discuss, among other issues, how sections of Class A water, that are bounded by stocked sections, should be marked or visually designated so that not only PFBC staff and stocking personnel, both professional and volunteer, know where the boundaries are, but also the anglers who are clearly unaware of these designated sections as well. We have several innovative concepts to suggest which would minimize the effort required, reduce angler concerns, but still provide the intended result of information and education that we have documented to be lacking for waters such as the South Fork and no doubt others statewide that have similar multiple management designations.

Thank you for your attention to our comments and we look forward to working with you cooperatively to improve the natural resources and recreational opportunities in the Bens Creek watershed and similar waterways throughout the state.
